### **Explanation with regard to the „Regulation (EU) No. 1907/2006“ of the European Parliament and Council of the 18th of December 2006 for Registration, Evaluation, Licensing and Restriction of Chemical Materials (REACH), published on the 30th of December 2006 in the official EU-bulletin 396/1.**

Dear Sirs,

you obtain from us exclusively non-chemical products (transformers, converters, chokes), from those, under normal and wisely predictable use terms, no chemical material can be released.

We hereby inform you that our products are not contain any particularly worrying Substances (SVHC) on the ECHA candidate list (as of 27. June 2024) over 0.1% by mass percentage accordance to Article 33 of the REACH regulation (Regulation (EC) No. 1907/2006) as well as restricted substances from its Annex XVII.

We herewith explain that the products delivered by us keep the limit values of the chemicals published up to now by ECHA.
